Drugs of abuse screening tests detect the presence of various classes of abused drugs. Request the drug of concern using the test mnemonic, or choose a panel for a comprehensive screening approach.

The following screening tests are available:

- The 10 panel qualitative cassette screening (Qualitative lateral flow immunoassay methodology) is the most cost-effective option and suitable for single/low number patient testing. Limitations include the absence of quantification, manual testing and subjective interpretation. This panel does not include Cat, Ecstasy or Mandrax and these tests can be requested as separate tests, additionally. PCP and TAD can only be requested as part of this panel.
- The 10 panel quantitative screening combines the immunoassay (7 analytes) and LC-MS/MS (3 additional analytes) methodology. This panel is automated, suitable for high number patient testing and renders quantitative results. Barbiturates, PCP or TAD are not included and can be requested as single tests.

The above screening tests have a faster turnaround time (24 hours).

Confirmatory tests (LC-MS/MS) are available to confirm positive screening results, ideally on the same urine specimen as a follow up collection may yield negative results if collected after the detection period. Confirmatory tests offer excellent specificity and analytical sensitivity at much lower levels than screening tests. The turnaround time of confirmatory tests is longer.

Specimen requirements

A random urine sample is required.

In cases where the results may be used for medico-legal purposes, a chain-of-custody procedure should be followed for the whole drug testing process, including specimen collection, screening and confirmation testing. The screening and confirmation testing should be done on the same specimen in these cases.
